

- We have already started seeing higher commodity prices due to the ongoing geopolitical tensions and any further escalations are likely to lead to further increases, especially in the short term.
- The reaction from central banks to higher energy prices by increasing interest rates to combat inflation, or reducing their pace of tightening to support the economy, will be a key development to watch out for. At this point, we expect central banks to prioritise growth, resulting in a more gradual policy normalisation cycle as they acknowledge the downside risks from higher commodity prices.
- We believe that there is still considerable pent-up demand and a strong household balance sheet and savings rate, mean developed world consumers are in a better shape to support the economic expansion over the medium term.
- Historically, geopolitical events, even those involving major energy producers, have not had a lasting impact on markets. While the ongoing geopolitical tensions and the prospect of higher interest rates may spark occasional bouts of volatility, we still believe the outlook for equities remains positive.

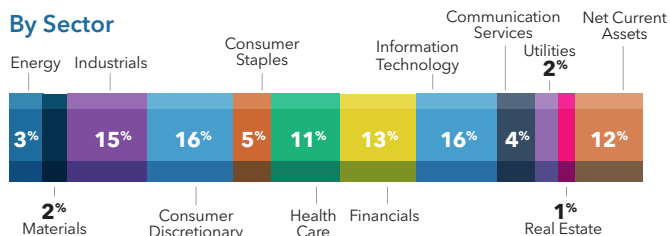

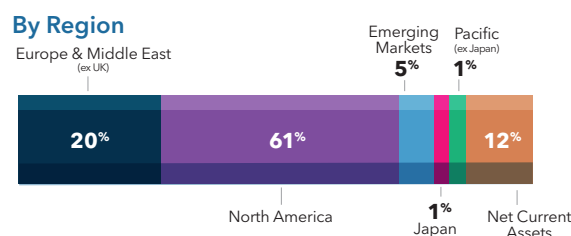

Distribution of total assets (28 February 2022)

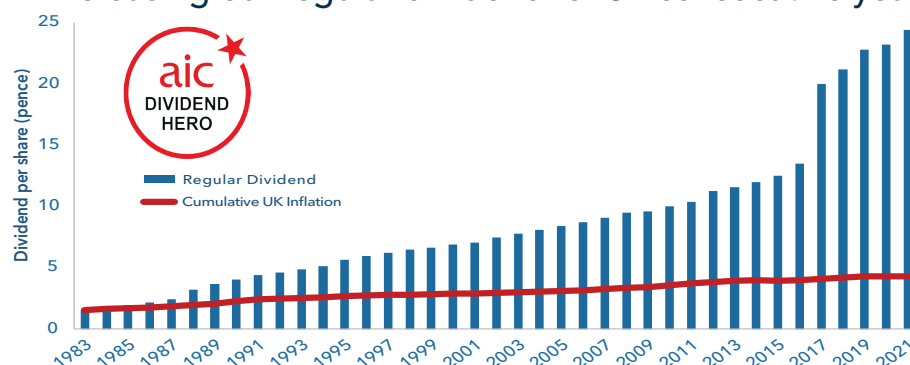
By Sector
